1. The procurement shall be completed in accordance with the Punjab Procurement Rules 2014.
2. Bidders are required to submit the 2 % bid security, in shape of CDR as mentioned in the tender document.
3. Only Authorized dealers /Firms/ Manufactures of above mentioned items should apply and also provide the certificates of genuineness and newness from the principal, original import certificate etc.
4. Only GST registered companies/firms can apply.
5. 3 Years Parts and Labor warranty for all the components on site for the quoted equipment.
6. Maximum of 48 hours down time for all components including replacement of the whole unit anywhere in the province.
7. The bidders should clearly mention Terms and Conditions of service agreements for the supplied hardware after the expiry of initial warranty period.
8. The bidders are required to participate for the whole LOT on turnkey basis.
9. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or Proposal.(Rule35(1))PPRA 2014
10. Bids must be submitted in the office of Additional Director General, Competent Authority(Procurement) Excise, Taxation & Narcotics Control ,Punjab 847-A, Shadman-I, Lahore in sealed envelop on 8 February 2017 (by 1200Hrs). The tenders shall be opened on 8 February 2017 at 1400 Hrs.

Interested parties are required to submit a bid amount of Rs. 1,000(Non-refundable), in shape of Bank Draft in favour of Director General, Excise, Taxation & Narcotics Control Department Punjab at the time of procuring the tender document/RFP.
